

**List of resolution authorities designated for the purposes of Regulation (EU) 2021/23 on a framework for the recovery and resolution of central counterparties (CCP RRR)**

Article 3(1): "Each Member State shall designate one or more resolution authorities that are empowered to apply the resolution tools and exercise the resolution powers as set out in this Regulation.

Resolution authorities shall be national central banks, competent ministries, public administrative authorities or other authorities entrusted with public administrative powers."

Article 3(10): "Member States shall notify the Commission and the European Supervisory Authority (European Securities and Markets Authority) (ESMA), established by Regulation (EU) No 1095/2010, of the resolution authorities designated pursuant to paragraph 1."

Article 3(12) "ESMA shall publish a list of the resolution authorities and the contact authorities notified pursuant to paragraph 10"
