DECISION OF THE BOARD OF SUPERVISORS

Appointment of the Securities and Markets Stakeholder Group The Board of Supervisors

Having regard to Regulation (EU) No 1095/2010 of the European Parliament and of the Council of 24 November 2010 establishing a European Supervisory Authority (European Securities and Markets Authority), amending Decision No 716/2009/EC and repealing Commission Decision 2009/77/EC¹ (the "Regulation" and "ESMA"), and in particular Article 37 thereof

Whereas:

- (1) The Committee of European Securities Regulators, as the predecessor of ESMA, issued a call for expressions of interest regarding the setting up of ESMA's Securities and Markets Stakeholder Group on 26 November 2010 (CESR/10-1466).
- (2) The Group reflects appropriate geographical and gender balance and representation of stakeholders across the Union to the extent possible, taking account of the need also to appoint candidates with appropriate expertise and to achieve a balance as between financial market participants, employees' representatives and consumers, users of financial services and representatives of small and medium enterprises.
- (3) In view of the important contribution the Group is expected to make to ESMA's work, it is desirable to establish a reserve list in order to quickly and efficiently fill any vacancies that should arise, taking account of the balance of the Group required by the Regulation. A mechanism should also be established to ensure that all members make a full contribution to the Group's work.

Has adopted this decision:

- The individuals in Annex 1 to this decision are appointed as members of the Securities and Markets Stakeholder Group (the "Group").
- The individuals shall serve for a period of two and a half years. The term of the Group shall commence on a date to be determined by the Chairperson.

The Chairperson shall maintain an alternates list comprising the individuals in Annex 2 to this decision.

- If a vacancy in the Group arises or is expected to arise, the Chairperson shall recommend to the Board of Supervisors an individual from the reserve list to fill the vacancy for the remainder of the Group's term.
- If a member does not attend three of the Group's meetings in a twelve month period (starting from the first meeting of the Group), or make an adequate contribution to the Group's work, the Board of Supervisors may on the advice of the Chairperson and having consulted the Chair of the Group and having given the member an opportunity to express his or her views on the matter, decide to replace the member with an individual from the reserve list for the remainder of the Group's term.

This decision enters into force on the day after its adoption.
