ESMA Data on Prospectuses Approved and Passported – January 2012 to June 2012

## I. Executive Summary

ESMA believes it to be useful to collect statistical data in relation to the number of prospectuses approved and passported by the National Competent Authorities on a regular basis (with quarterly disclosure).

The history of these reports is that ESMA's predecessor CESR initiated the practice by publishing in June 2007 its "Report on the supervisory functioning of the Prospectus Directive and Regulation" (CESR/07-225) which included such statistical data for the periods from July 2004 to June 2006.

Despite the limitations and caveats highlighted when publishing the data, the initiative was considered very useful and was welcomed by the European Commission and market participants. For this reason, the exercise was formalised and data was collected on a regular basis.

Earlier reports were published on 13 June 2008 with tables compiling the data for the period July 2006 to June 2007, on 10 July 2008 with data for the period July 2007 to December 2007, on 14 October 2008 with data for the period January to June 2008, on 30 March 2009 a compilation of the data for the period July 2008 to December 2008, on 18 September 2009 with data for the period January 2009 to June 2009, on 11 March 2010 with data for the period July 2009 to December 2009, on 27 October 2010 with data for the period July 2010 to June 2010, on 28 March 2011 with data for the period July 2010 to December 2010, and on 25 September 2012 with data for the period January 2011 to December 2011.

Following these publications, ESMA is publishing today the tables below compiling the data for the period January 2012 to June 2012 (with a quarterly disclosure).

**NOTE**: This Report is an amended version of the Report published on 25 September 2012. The previously published Report was amended on 15 May 2013 following the discovery of factual errors in the statistical information in Section III.2.

The tables reflect the information as provided by the National Competent Authorities to ESMA. It is important to note that the National Competent Authorities have different internal databases in place that might lead to some divergences in the data provided.


