## 3. Report by Chair and Executive Director Oral information

The Chair reported on;

- the recent decision by the Board of Appeal to dismiss an appeal against the decision by ESMA to refuse the registration of Global Private Rating Company "Standard Rating" Ltd as a credit rating agency, and the European Court of Justice judgment on ESMA's power to adopt emergency measures under the SSR;
- the status of incorporation of the ESMA Regulation into the EEA Agreement and the participation by national competent authorities from EEA/EFTA States in the work of ESMA as observers;
- the complaint to the European ombudsman against ESMA regarding the 2011 SMSG election; and
- an amendment made to the decision on ESMA's Financial Regulation following the adoption by the Management Board last December.

The Executive Director reported on;

ESMA's response to the recommendations and questions by the Budgetary Authority in the discharge process; and



the possibility to have short term secondments at ESMA. An explanatory note on short term secondments will be provided to the members of the Board of Supervisors.

The senior accountant presented an overview of the contributions and fees to be paid by national competent authorities in 2014. The overview will also be provided to the members of the Board of Supervisors.

The Executive Director and the Head of the Operations Division presented the 2014 regulatory work programme.

The Board discussed the report, in particular the timeline and possible prioritisation of the activities on MiFID/MiFIR. A high-level indication of the timeline of these activities will provided to the Board of Supervisors at a future meeting.

**Decision:** The Board approved the 2014 regulatory work programme for transmission to the Board of Supervisors for their approval at the 6 February 2014 meeting. Members were asked to send any final drafting comments by the end of the week.

The Executive Director and the Head of Operations presented the documents on the 2015 planning.

The Board discussed the reports, in particular;

- the 2015 budget request and multi-annual staff policy plan in relation to the EU multi-annual financial framework 2014–2020;
- to further prioritise between the different areas, focussing more on the key operations (IT, HR)
   and supervisory convergence; and
- the large increase in administrative expenditures and fees to be paid by Trade Repositories.

**Decision:** The Board approved the 2015 budget request, the 2015 high-level work programme and the 2015-2017 multi-annual staff policy plan for transmission to the Board of Supervisors for their approval at the 6 February 2014 meeting.



The European Commission opposed the 2015 budget request and the staff numbers in the MSPP as being inconsistent with its Communication of 10 July 2013 on the programing of human and financial resources for decentralised agencies 2014-2020.

The deputy Ethics Officer presented the conflicts of interests policy.

The Board discussed the report, in particular;

- supporting the need for such a policy and to raise awareness fof the obligations;
- the existing requirements on professional secrecy for members of the Board of Supervisors;
- to have a clearer distinction in the document between the requirements for ESMA staff and members of the Management Board and Board of Supervisors;
- to have more precise wording regarding the distinction between obligation Board members face as being both Head of a national competent authority and an ESMA Board member;
- the compatibility of the obligations with national requirements;
- to clarify the position of observers in the Board of Supervisors;
- the obligation to professional secrecy regarding professional activities after leaving ESMA;
- to apply the principal of proportionality on the requirements for the different actors involved;
- to further clarify the requirements on the confidentiality of information, in particular relating to documents received by members of the Boards and the distribution of these documents to their staff;
- the scope of the principles for publications and speeches; and
- the supporting rules and guidelines, in particular from the European Commission, for the policy.

**Conclusion:** The policy will be revised taking into account the discussion in the Board and circulated for written comments. The revised policy on conflicts of interests will then be discussed at the next meeting of the Management Board.
