## **Notes**

Article 16(3) of the ESMA Regulation requires national competent authorities to inform us whether they comply or in-tend to comply with each guideline or recommendation we issue that applies to them within two months of the guide-line or recommendation being issued. If a competent authority does not comply or does not intend to comply it must inform us of the reasons. We decide on a case by case basis whether to publish reasons.

- \* This table shows the compliance position of the competent authorities which are members of ESMA's Board of Supervisors as well as two other authorities which have notified ESMA of their compliance position, namely the UK BoE and the UK PRA. The EEA States other than the Member States of the European Union are not currently required to notify their compliance with ESMA's Guidelines. This table is based on information provided from those EEA States on a voluntary basis. ESMA has not received compliance notifications from any other competent authorities.
- \*\*The United Kingdom formally left the EU on 31 January 2020, following which the withdrawal agreement entered into force. The withdrawal agreement marked the start of a transition period which lasted until 31 December 2020, whereby the UK was no longer an EU Member State but EU law continued to apply to it. The compliance status recorded in this table for the competent authority of the United Kingdom therefore reflects their compliance status as at 31 December 2020 and is retained for the purpose of historical information. Please note that, from 1 January 2021, EU law no longer applies to those competent authorities.
